We hope you're weathering this month with plenty of Valentine's Day chocolate on hand. I'm writing to share testing updates, details about Regular Decision release, and resources for Transfer applicants. Click <u>here</u> to skip to the highlights.

Testing Updates

Earlier this month, we shared that Northwestern's test-optional policy will continue for undergraduate first-year and transfer applicants. Applicants may submit an SAT or ACT score if they wish, but these scores are not required. With or without test scores, we evaluate applicants' academic and intellectual fit for Northwestern through holistic review of grades, course rigor, recommendations, academic honors or awards, writing supplements, and other information specific to students' own experiences.

For students who choose to submit an ACT, we will not require the science section when it becomes optional in the coming months. Students who self-report scores should report their highest ACT section scores across test dates and their highest composite score from a single test date; our system will calculate the ACT superscore.

Regular Decision Candidates: Decision Release & Pool-wide Context

We'll release Regular Decision results on Wednesday, March 26th. Applicants will receive an email letting them know a decision is available in their applicant portal.

While we cannot share any decision-related information with counselors prior to March 26th, we'll provide poolwide context to counselors at that time to help guide your conversations with students and families. On March 26th, we'll make this contextual information available via our online counselor hub and will email a link to all counselors listed on an RD School Report form. (Note: if your email is not listed on the school report form, you can still access the information online on our counselor hub.)

Counselors with a Slate.org account can view the status of their students' applications after a student has viewed their decision. You can create an account on Slate.org if you do not currently have one.

While we cannot discuss individual decisions with counselors, we welcome connections after decision release should you need decision information or have any follow-up questions. Please refer to our <u>regional teams</u> webpage for the appropriate direct contact on our Admissions team.
